## REPORT FROM THE CHAIR

FSYR has had another very successful year delivering responsive, high quality, impactful programs and services as is evident by our client satisfaction scores of 94%. Above and beyond these exceptional results, the Board has been most impressed with FSYR Staff's passion, drive and creativity in challenging the status quo when it comes to service delivery. A prime example of this is the innovative development of a new service access model aimed at reducing barriers and wait times for services. To complement this new initiative, and support our clinicians and admin staff, FSYR has also implemented a new group supervision model aimed at growing our expertise and enhancing our culture of team support. These initiatives have been presented to the Board over the past year, and we are very proud of the high standards that have been established, in pursuit of the exceptional outcomes that we continue to see year over year.

What is particularly notable about FSYR's management team, is the high value placed on staff input for the development of new initiatives. We have seen this in many forms from 360 surveys, to suggestion boxes, to quarterly town hall meetings, and focus groups. The Board appreciates the time, energy and commitment that go in to being a "bottom up", feedback informed organization, where all staff are valued for their voice in our growth and development.

At the community level, FSYR has continued to be a strong collaborative partner with York Region's Children's Mental Health Sector, the Violence against Women Sector, Youth Justice, the Boards of Education, United Way Anchor Agencies and a host of community partners, all engaged with us in serving York Region Residents. These cooperative, collaborative efforts are key in strengthening the region's social safety net. As a United Way Anchor Agency, we are most appreciative of the United Way Anchor funding that supports Social and Systems Change, and helps us to strengthen these collaborative efforts.

We are very grateful to our York Region and Provincial Funders, United Way Greater Toronto, and the Ontario Trillium Foundation for investing in our programs and services. As is evident from our outcomes, the Social Return on your Investments is exceptional, as we continue to demonstrate high value for every dollar spent. We are particularly grateful to the Ontario Trillium Foundation, funded by the Province, for the Capital and Grow grants received this past year that have helped us to enhance our Gold Standard FAST Program, and renovate our group therapy and viewing rooms, respectively.

There is no doubt that FSYR's success today has been achieved through the dedicated efforts of our volunteers, staff, and management under the able leadership of our Executive Director Elisha Laker. Congratulations and thank you all for a job absolutely, wonderfully done.

## REPORT FROM THE EXECUTIVE DIRECTOR

A couple of months ago, I came to the office and there was a woman, lying on the floor next to our doorway – shocked, concerned, and not sure if she was injured, sick or perhaps even worse, I approached and asked her if she was ok. In a somewhat nonchalant manner she replied – I'm ok just tired and waiting for my son who is getting therapy. She was tired because any single mom with 5 kids no doubt would always be tired, and on top of that, she walked from her home, a good couple of miles or so from our office, with her son, for his appointment. I invited her in and we provided her with a space to rest in privacy, until her son's session was finished. A newcomer to Canada, from a refugee camp in Ghana, she was referred through Victim Services due to a violent relationship with her husband that traumatized herself and her kids. Her youngest child became non-verbal, and her older kids were fighting at school, stealing and somewhat out of control. This mom was grateful for a place to rest and very grateful for the supports, and skill of our therapist who through, some play therapy and family therapy, has helped this family to begin to heal and stabilize.

At a school in one of our high needs neighbourhoods, a newcomer, single parent attended one of our after school Families and Schools Together programs – it was winter when she attended and she was wearing slippers to the program, as she couldn't afford boots or shoes. With 5 children ages 3 to 14, she lives in subsidized housing and let us know that she makes sure that her kids eat first as there often isn't enough food for herself; as a result she often has health issues. She had been involved with Child Welfare and 1 of her children no longer lives with her... how brave of her to attend our program. The FAST Program helped her to connect with us and she has continued to stay involved with us through our outreach services. Most importantly she is beginning to trust us. A very big gain given her experience.

Our Intake Staff recently called a client on our wait list who had requested couple counselling. When our staff spoke to the client, she was quite distraught and told us that couple counselling was no longer necessary as her partner had committed suicide. He had been struggling with mental health issues for years. We offered her an immediate Single Session Consultation which she was most grateful for as she was really struggling – she was a caregiver by profession and felt horribly responsible for the death of her husband, was riddled with guilt wondering why she couldn't have saved him. In this 90 minute session we helped to comfort and stabilize her, provided her with some coping skills and most importantly some hope about the future, along with resources to support her through her grief.

Day in and day out, the people who come through our doors face some of life's most difficult events and painful, often tragic experiences. When they leave our doors, over 94% report they are satisfied with the service they have received and 75% report they are better able to cope and deal with the situation that brought them in for service. These remarkable results are due to the skill, expertise, kind heartedness, and generosity of our talented staff and volunteers, all anchored by the diligence, support and dedication of our Board. Thank you all for your inspired contributions.

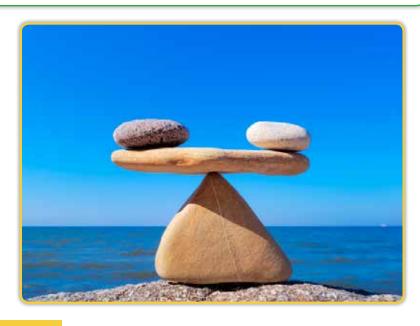
